The National Society United States Daughters of 1812 awards an \$1,812 scholarship to presently enrolled college students who plan to major in history, history education or a related field with an emphasis in American history from its founding through the 19th century. Applicants must be citizens of the United States and currently attending an accredited college or university in the United States, pursuing an Associate's or Bachelor's degree. The applicant should have maintained a minimum 3.0 GPA. Awardees may apply for this scholarship more than one time.

Each student should complete the application, gather additional required documentation, and submit everything to the Chairman National, 1812 Scholarship Committee no later than DECEMBER 31. Do not submit a photograph.

For states and chapters, the application is located on the N.S.U.S.D 1812 member's website.

Scholarships are awarded without regard to age, race, religion, sex, or national origin. Awards are based on academic excellence and financial need. Neither applicants nor their families need be members of N.S.U.S.D 1812.

Winners will be notified by the Chairman National in February. Winners will be invited to accept their award at the Associate Council in April. Expenses will not be paid by 1812. Scholarships are sent to the college by the Treasurer National in late July or early August. Any unused portion of the award must be returned.

One letter of recommendation should be on college letterhead, from a professor at your current institution. This letter should speak to your academic ability as well as commitment to History. The other can be from community service, work supervisor, etc.
- A resume or personal biography (less than 350 words).
- A list of extracurricular activities, honors, awards, significant accomplishments and jobs.
- Scholarship Financial Need Form (next page).
